### Definition of Unskilled, Semi-skilled, Skilled & Highly Skilled Workers

## UN-SKILLED

An unskilled employee is one who does operations that involve the performance of simple duties, which require the **SEMI-SKILLED** 

A semiskilled worker is one who does work generally of defined routine nature wherein the major requirement is not **SKILLED** 

A skilled employee is one who is capable of working efficiently of exercising considerable independent judgement and **HIGHLY** - **SKILLED** 

A highly skilled worker is one who is capable of working efficiently and supervises efficiently the work of skilled

#### **ZONE CLASSIFICATION**

**Zone-1** Consists all muncipal corporations.

**Zone-2** Consists all Major muncipalities which have more than 1 lakh population.
